The designated judge will handle EWarrants during their full week of duty, plus weekend jail duty. On HOLIDAYS the designated judge will handle jail duty. Jail duty includes initial appearances, shelters and detention hearings. If the clerk's office is open on a judicial holiday, the HOLIDAY judge will cover all injunctions, and Baker and Marchman act signing.

On non-holidays, all injunctions, Baker and Marchman act signing is covered by other duty schedules. This includes all petitions filed during regular business hours through the clerk's office.
